Employee Salaries	\$ 152,549	Your hard-working parish staff is dedicated to making our parish community the best ever.
Employee Benefits	72,640	Employment benefits are required by law and by diocesan statute for all our staff members.
Repairs & Maintenance	45,747	These are ordinary repair and maintenance costs for our parish facilities this year.
Buildings & Grounds	84,209	These are ordinary buildings and grounds expenses for our parish facilities this year.
Materials & Supplies	19,212	These are ordinary material and supply expenses for our parish facilities this year.
Capital Expenditures - Mechanical	28,664	These are special capital expenditures that were needed for our parish facilities this year.
Interest Payments - Diocesan Loan	12,633	This is the interest paid on the initial diocesan loan for our new roof and parking lot.
Principal Payments - Diocesan Loan	12,321	This is the diocesan loan reduction for our new roof and parking lot, at an interest rate of 4%.
Equipment Rental Expense	3,450	It is more cost-effective to rent our copiers and other equipment rather than to buy them.
Property & Liability Insurance	15,430	This insurance is required by law and by diocesan statute for all the parishes in our diocese.
Parish Utilities Expense	68,818	What are your home utility bills? We have a large church facility and parish campus!
Diocesan Assessments	79,859	The diocese needs the ongoing support of all the parishes in order to fulfill its leadership role.
Liturgy and Music Program	72,534	The devout celebration of the Sacred Liturgy is at the heart of our parish spiritual life.

**Net Parish Income for this Fiscal Year**      \$      **98,529**      Please see the information below concerning our parish loan for the new roof and parking lot.

**About our Parish Debt.** In the last two fiscal years, we spent a total of \$545,849, for a new roof and a new parking lot, which were urgently needed for our parish.

The diocese provided us with a loan of \$430,000, for these two projects.  
We have already paid \$128,170 of the total expenses, but we still owe \$417,679 on the loan.

Terms of the April 2017 loan: ten-year amortization, with monthly P&I payment of \$4,354, at 4% interest, and with a balloon payment of \$191,484, at the end of five years.

Thank you for your ongoing generosity that not only helps us meet our day-to-day parish expenses, but also helps us retire our parish debt. May God bless you always!
