## 2025 FALL LANDSCAPE INSTALLATION PER DESIGN #25.117M-AD

### SECTION 1 ~ REMOVALS, BED PREP, INSTALL TREES, SHRUBS & PERENNIALS

Clarence Davids & Company proposes to perform the following work on the west side of the school:

- Contractor will remove existing Viburnum, Burning Bush, Boxwood, and miscellaneous yellowing shrubs around the garage and on the west side of the school.

- Contractor will cut out new bed lines, where shown on the plan, and dig a natural spade cut edge around the beds. Amend the existing soil with compost, supply and install the following plants:

- 2 2" American Hornbeam
- 6 6' Eastern Redbud
- 13 5 gallon Densi Yew
- 5 3 gallon Blackhaw Viburnum
- 11 3 gallon Iroquois Beauty Black Chokeberry
- 10 5 gallon Vernal Witchhazel
- 5 5 gallon Neon Burst Dogwood
- 6 3 gallon Scentlandia Virginia Sweetspire
- 10 3 gallon Bobo Hydrangea
- 14 1 gallon Northwind Switch Grass
- 12 1 gallon Carnival Watermelon Coralbells
- 8 1 gallon Maidenhair Fern
- 34 1 gallon Millenium Allium
- 16 1 gallon Zagreb Coreopsis

- Contractor will mulch the beds using blended shredded bark mulch.

- Contractor, where beds are not planted, will remove existing mulch, cover with a light layer of topsoil, apply starter fertilizer, overseed with Sunny Grass Seed and cover with straw blanket secured with staples.

- Contractor will supply and install Wisconsin Boulders 4"-8" to worn sidewalk edges were shown on plan.

- Contractor will water plants in well (1) time at planting and up to (8) additional waterings to help get plant material properly established.

Fall is optimal planting time!

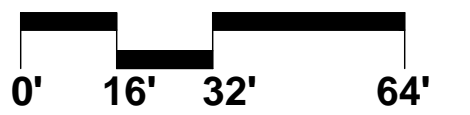

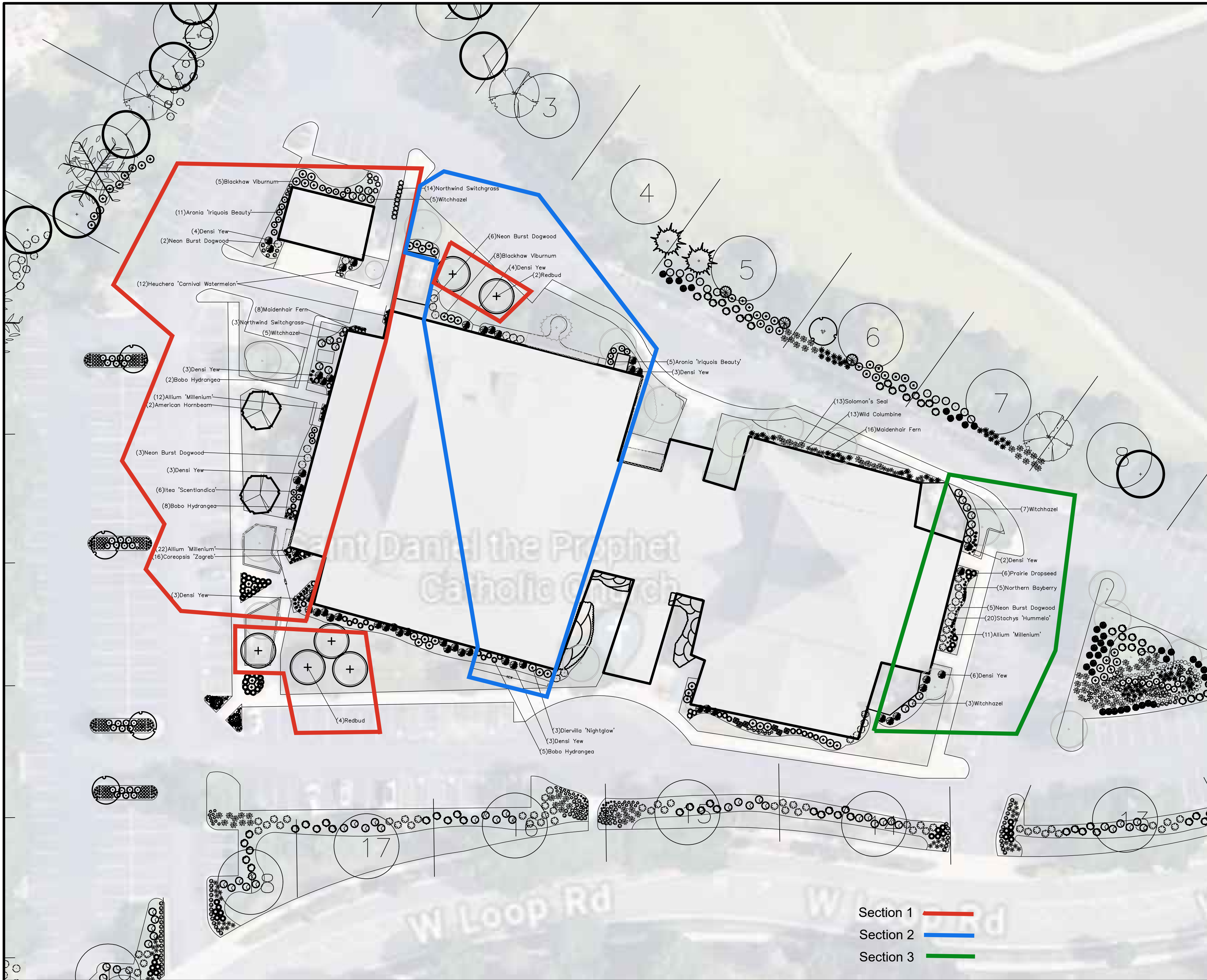
